Official Terms and Conditions:

1. **Offer Overview:** Subject to the terms, conditions and restrictions set forth below, BASF Canada Inc. (“**BASF**”) is offering (the “**Offer**”) each Eligible Participant (as defined below in Section 3) the opportunity to receive a Rebate (the “**Rebate**”) and a Bonus Rebate (the “**Bonus Rebate**”) on qualifying purchases of Qualifying Products (as defined below in Section 7). The value of the Rebate (and, if applicable, Bonus Rebate), if any, that an Eligible Participant (as defined below in Section 3) is eligible to receive pursuant to this Offer will be calculated by BASF, in its sole and absolute discretion, in accordance with these Official Terms and Conditions (the “**Terms**”).
2. **Offer Period:** The Offer begins October 1, 2017 at 7:00 a.m. Eastern Time (“**ET**”) and ends September 30, 2018 at 11:59 p.m. ET (the “**Offer Period**”).
3. **Eligibility:** The Offer is open to Canadian growers who: (i) reside in Alberta, Manitoba, Saskatchewan, or British Columbia (Peace Region); (ii) are the owner, operator or designated representative of a farm (the “**Farm**”); and (iii) have reached the legal age of majority in their province of residence (each, an “**Eligible Participant**”). These Terms govern this Offer and must be followed by all Eligible Participants at all times. By agreeing to participate in the Offer, each Eligible Participant is signifying his/her agreement to comply with, and be legally bound by, these Terms.
4. **How to Qualify for a Rebate:** To qualify for the Offer and be eligible to receive a Rebate, an Eligible Participant must:
 - a. Comply with all of the terms and conditions set forth in these Terms (as determined by BASF in its sole and absolute discretion); and
 - b. During the Offer Period, make qualifying purchases (from an authorized Western Canadian retailer(s)) that consist of:
 - i. a minimum of forty (40) acres of VIPER® ADV herbicide; and
 - ii. a minimum of **one** (1) qualifying crop protection product from **either** of the following two (2) BASF Brand Categories (each, a “**Brand Category**”):
 - Brand Category #1 – on-seed inoculants: NODULATOR® PRO, NODULATOR N/T LQ, NODULATOR N/T SA PEAT
 - Brand Category #2 – in-furrow inoculants: NODULATOR LQ, NODULATOR GRANULAR, NODULATOR SCG.

Prior to qualifying for the Offer, the Eligible Participant will be required to accept and agree to be legally bound by these Terms. In addition, the Eligible Participant will have the opportunity to agree to the terms and conditions contained within the BASF Grower Privacy Consent and the BASF Commercial Electronic Messages Consent (the “**Consent Forms**”). An Eligible Participant may subsequently withdraw his/her consent to receive electronic communications at anytime without affecting their eligibility for this Offer.

If an Eligible Participant completes all of the foregoing steps in accordance with these Terms (as determined by BASF in its sole and absolute discretion), then the Eligible Participant will be eligible to qualify for the Offer and to receive the Rebate. **There is a limit of one (1) Rebate per Farm.**

5. **How to Qualify for a Bonus Rebate:** An Eligible Participant that qualifies for a Rebate in accordance with these Terms (as determined by BASF in its sole and absolute discretion) will also be eligible to receive a Bonus Rebate if, during the Offer Period, he/she makes qualifying purchases (from any authorized Western Canadian retailer(s)) that, in addition to the purchase requirements outlined above in Section 4, consist of a minimum of forty (40) acres of INSURE® PULSE

The Bonus Rebate is in addition to the Rebate. **There is a limit of one (1) Bonus Rebate per Farm.**

6. **Rebate and Bonus Rebate Calculation:** The value of the Rebate (and, if applicable, Bonus Rebate), if any, that an Eligible Participant is eligible to receive pursuant to this Offer will be calculated by BASF, in its sole and absolute discretion, in accordance with these Terms, as follows:

- Earn a **\$2.00 CDN/acre Rebate** on **matching acres** by completing the following transaction:
 - i. Purchase (at a minimum) forty (40) acres of VIPER ADV that is matched with a minimum of one (1) qualifying crop protection product from **either** of the following two (2) BASF Brand Categories: Brand Category #1 or Brand Category #2

 - i. Purchase (at a minimum) forty (40) acres of VIPER ADV that is matched with a minimum of one (1) qualifying crop protection product from **each** of the following two (2) BASF Brand Categories: Brand Category #1 and Brand Category #2.
- **Earn an Additional \$1.00 CDN/acre Bonus Rebate** on each matching acre of INSURE PULSE; provided that the forty (40) acre minimum is met.

*Note: For the purpose of Rebate and Bonus Rebate calculations, purchases of NODULATOR PRO, NODULATOR N/T LQ, and NODULATOR N/T SA PEAT are combined as one (1) qualifying Brand Category #1 Product. Retailers have complete autonomy to determine the resale pricing for the products described herein and may choose to sell such products at prices which are different from those suggested by BASF. Rebates (and, if applicable, Bonus Rebate), will be calculated on a per matching acre basis, using all Qualifying Products (as defined below in section 7) purchased from any authorized Western Canadian retailer(s) in accordance with these Terms, including partial cases.

7. **Qualifying Products and Acres:** For the purposes of the Offer, VIPER ADV, Brand Category #1 products, Brand Category #2 products and INSURE PULSE, (collectively, the “**Qualifying Products**”) will have the following label rates:

8. **Verification:** BASF reserves the right, in its sole and absolute discretion, to require proof of identity and/or eligibility (in a form acceptable to BASF): (i) for the purposes of verifying an Eligible Participant’s eligibility to participate in this Offer; (ii) for the purposes of verifying the legitimacy of any Data (as defined below in Section 10c), Qualifying Products and/or other information; and/or (iii) for any other reason BASF deems necessary, in its sole and absolute discretion, for the purposes of administering this Offer in accordance with BASF’s interpretation of the letter and spirit of these Terms. Failure to provide such proof to the complete satisfaction of BASF within the timeline specified by BASF may result in disqualification in the sole and absolute discretion of BASF. All determinations regarding whether or not an Eligible Participant is eligible to earn a Rebate (and, if applicable, a Bonus Rebate) in accordance with these Terms will be made by BASF in its sole and absolute discretion. If it is discovered by BASF (using any evidence or other information made available to or otherwise discovered by BASF) that any Eligible Participant (or any person or entity purporting to be an Eligible Participant) has attempted to use multiple names, identities and/or any other means not expressly sanctioned by these Terms to participate in or disrupt this Offer, then he/she may be disqualified from the Offer in the sole and absolute discretion of BASF.
9. **Notification and Confirmation:** If an Eligible Participant has been deemed by BASF, in its sole and absolute discretion, to be eligible to qualify for the Offer and to receive a Rebate (and, if applicable, a Bonus Rebate), then the Eligible Participant may be notified by a representative of BASF. Without limiting the generality of the foregoing, BASF reserves the right, in its sole and absolute discretion, to substitute the Rebate (and, if applicable, the Bonus Rebate) or a component thereof with a reward of equal or greater retail value.
 12. Rebate cheques with a value of less than \$100 CDN will not be processed.

In the event of any discrepancy or inconsistency between the terms and conditions of these Terms and disclosures or other statements contained in any Offer-related materials and/or any instructions or interpretations of these Terms given by any representative of BASF, the terms and conditions of these Terms shall prevail, govern and control to the fullest extent permitted by law.
21. 23. The invalidity or unenforceability of any provision of these Terms shall not affect the validity or enforceability of any other provision. In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these Terms shall otherwise remain in effect and shall be construed in accordance with the terms as if the invalid or illegal provision were not contained herein.
24. To the fullest extent permitted by applicable law, all issues and questions concerning the construction, validity, interpretation and enforceability of these Terms or the rights and obligations of Eligible Participants, BASF or any of the other Released Parties in connection with the Offer will be governed by and construed in accordance with the domestic laws of the Province of Ontario and the federal laws of Canada applicable therein, without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other jurisdiction's laws. The parties hereby consent to the exclusive jurisdiction and venue of the courts located in Ontario in any action to enforce (or otherwise relating to) these Terms or relating to this Offer.
