

2013 Win with AgCelence Online Contest Terms and Conditions

Contest Overview:

Subject to the terms, conditions and restrictions set forth below, BASF Canada Inc. ("BASF") is awarding eligible growers (a) a BASF cap, (b) entry into a draw for one of five secondary prizes per BASF district, each consisting of a \$500 voucher and (c) entry into a draw for one grand prize per BASF district, each consisting of a trip for two to Hawaii for entering the Win with **AgCelence™** Online Contest (the "Contest").

Contest Details

- No purchase necessary. This Contest is open to Canadian growers who reside in Alberta, Manitoba, or Saskatchewan who: (i) are the owner, operator or designated representative of a farm (the "Farm"); and (ii) have reached the age of majority in their province/territory of residence, ("Eligible Recipients"). Employees of BASF, their advertising agencies and those residing with them are not eligible to enter this Contest or to win any prize.
- 2. In order to qualify for the Contest, Eligible Recipients must accept these Terms and Conditions. On entering the Contest, Eligible Recipients will have the opportunity to agree to the Terms and Conditions contained within BASF's Grower PIPEDA Consent and Commercial Electronic Messages Consent. Eligible Recipients may subsequently withdraw their consent to receive electronic communications, without affecting their eligibility in this Contest.
- 3. Eligible Recipients can enter the Contest at **www.agsolutions.ca/agcelence** by completing all of the following steps:
 - a) Watching the Science Behind **AgCelence** online video
 - b) Completing the Win with **AgCelence** online quiz
 - c) Either entering one of the unique codes received via email, direct mail or tradeshow hand out, and if prompted, following the onscreen instructions to submit their name and address information. If an Eligible Recipient does not have a unique code, they may enter the Contest without one by following the onscreen instructions to submit their name and address information.
 - d) Agreeing to be legally bound to the terms and conditions of these Official Rules and Regulations.
 - Eligible Recipients will receive one (1) entry into the applicable draw, based on their Region as described below, on completing this entry process ("**Entry**").
- 4. Limit of one (1) Entry per Farm/mailing address permitted during the Contest Period. If it is discovered by BASF (using any evidence or other information made available to or otherwise discovered by BASF) that any person has attempted to: (i) obtain more than one (1) Entry per Farm/mailing address during the Contest Period; and/or (ii) used (or attempted to use) multiple names, identities and/or any automated, macro, script, robotic or other system(s) or program(s) to enter or otherwise participate in or disrupt this Contest; then he/ she may be disqualified from the Contest in the sole and absolute discretion of BASF. Your Entry may be rejected if (in the sole and absolute discretion of BASF) the Entry form is not fully completed with all required information and submitted and received during the Contest Period. BASF is not responsible for late, lost, misdirected, delayed, incomplete or incompatible Entries (all of which are void).

- 5. This Contest begins January 1, 2013 at 12:00 AM, Eastern Standard Time and ends April 30, 2013 at 11:59 PM, Eastern Standard Time (the "**Contest Period**").
- 6. BASF assumes no responsibility for lost, delayed, incomplete, incompatible or misdirected contest Entries. This Contest is subject to all applicable federal, provincial and municipal laws. The decisions of BASF with respect to all aspects of this Contest are final and binding on all Eligible Recipients without right of appeal, including, without limitation, any decisions regarding the eligibility/disqualification of Eligible Recipients. BASF will not be liable for any technical malfunction or other problems relating to the telephone network or lines, computer online systems, servers, access providers, computer equipment or software; for the failure of any contest Entry to be received by BASF for any reason; or any combination of the above.

Any attempt to undermine the legitimate operation of this Contest may be a violation of criminal and civil laws and should such an attempt be made, BASF reserves the right to seek remedies and damages to the fullest extent permitted by law.

BASF reserves the right, in its sole and absolute discretion, to require proof of identity and/or eligibility (in a form acceptable to BASF potentially including, without limitation, government issued photo identification) to participate in this Contest. Failure to provide such proof to the satisfaction of BASF in a timely manner may result in disqualification. The sole determinant of the time for the purposes of a valid submission will be BASF's server machine(s).
- 9. In the event of a dispute regarding who completed the online Entry, the contest Entry will be deemed submitted by the person whose name and address was entered online at **www.agsolutions.ca/agcelence**.
- 10. - 12. A BASF district ("**District**") is a geographical region made up of BASF Business Representative sales Regions in Alberta, Saskatchewan and Manitoba. There are four (4) Districts: Alberta, Manitoba, Saskatchewan North and Saskatchewan South. Saskatchewan South is all regions south of Davidson, SK and Saskatchewan North is all regions north of Davidson, SK. Winners will be chosen among all eligible Entries in the same District; a contest entrant's District will be determined by their place of residence in Canada, as determined by BASF in its sole and absolute discretion.

Cap Offer Details:

- 1. Each Eligible Recipient will receive one (1) cap by entering the Contest. Approximate retail value of each cap is \$25.00.
- 2. Limit of one (1) cap per Farm.
- 3. The cap will only be shipped to a Canadian address. Please allow 6-8 weeks from April 30, 2013 for the mailing of the cap.
- 4. All caps must be accepted as awarded and are not transferable. No cash value will be given or substitution made for the caps.

Prize Details and Winner Selection:

- 1. There will be a total of four (4) grand prize packages (each a "Grand Prize") and twenty (20) secondary prize packages (each a "Secondary Prize"). All Entries from each District will be entered into one (1) draw per District. There will be one (1) Grand Prize awarded per District and five (5) Secondary Prizes awarded per District.
- 2. On or about May 9, 2013 (the "Selection Date") at approximately 2:00 PM ET, the BASF's independent judging organization in Mississauga, Ontario will conduct four (4) draws, one from among all eligible Entries received during the Contest Period from Eligible Recipients in each District. In each draw, six (6) Eligible Recipients will be selected, and the first Eligible Recipient so drawn will be the potential winner of a Grand Prize, and the second through sixth Eligible Recipient so drawn will be the will be the potential winner of a Secondary Prize. BASF, acting reasonably, will attempt to contact the selected entrants at the telephone number or e-mail address on record, within seven (7) days of the Selection Date. In the event a selected entrant cannot be contacted within seven (7) days of the Selection Date, he or she will be disqualified and an alternate selected entrant may be chosen from the remaining eligible Entries, in the sole and absolute discretion of BASF.
- Each Grand Prize consists of one (1) trip for two (2) adults to Maui, Hawaii. Grand Prize consists of: ten (10) nights standard hotel accommodation (based on one room, double occupancy) as chosen by BASF; and \$900 CAD spending money that the winner could use towards food, beverages and other out of pocket expenses, solely at their discretion.
