

Offer Overview:

Subject to the terms, conditions and restrictions set forth below, BASF Canada Inc. o/a BASF Canada (“**BASF**”) is offering Eligible Recipients (as defined below) the opportunity to earn one (1) S’Well water bottle (approximate retail value \$40.00 CAD) (a “**Reward**”) for completing the BASF Learning Centre Program Module entitled: InVigor RATE Learn and Earn (the “**Module**”) during the Offer Period (defined below) (the “**Offer**”). Each Eligible Recipient (subject to the limit of one (1) Reward per Farm) that qualifies for the Offer pursuant to these Official Offer Terms and Conditions (as determined by BASF in its sole and absolute discretion) will be eligible to receive one Reward.

Offer Details:

1. No purchase necessary.
